The DPR Korea celebrates its 60th founding anniversary this year.

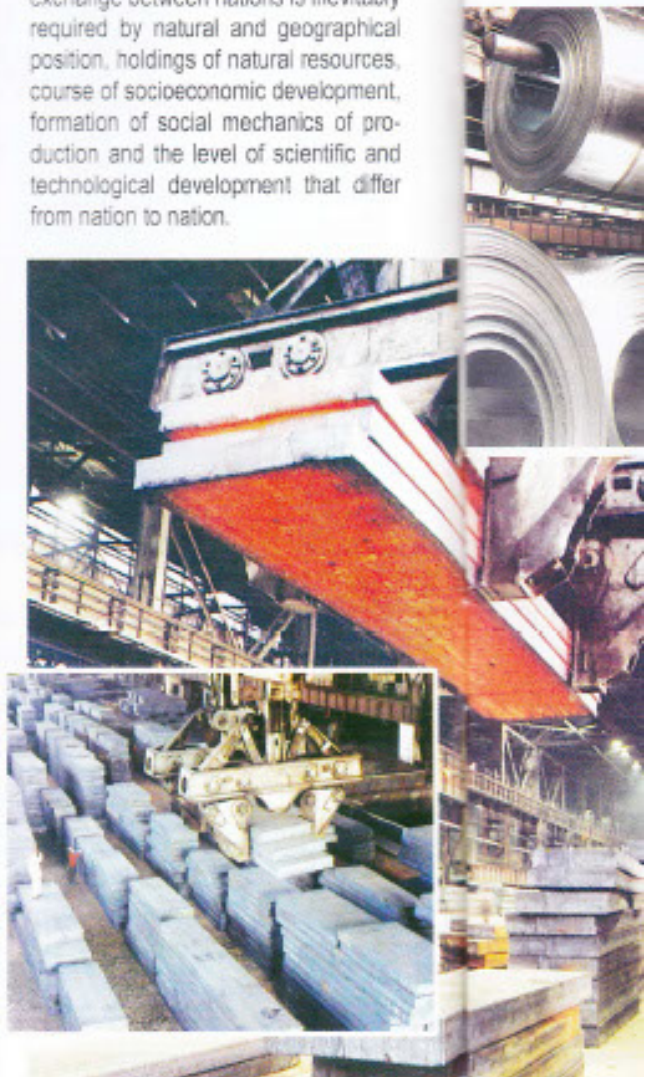
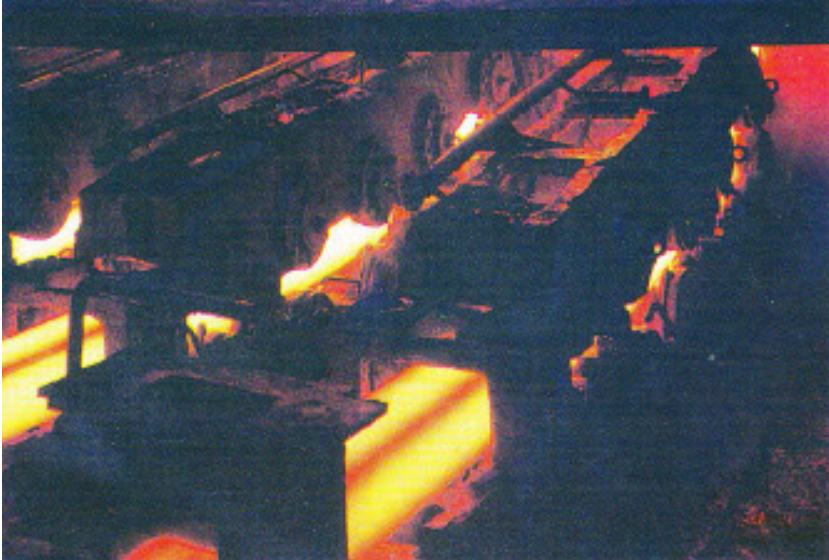
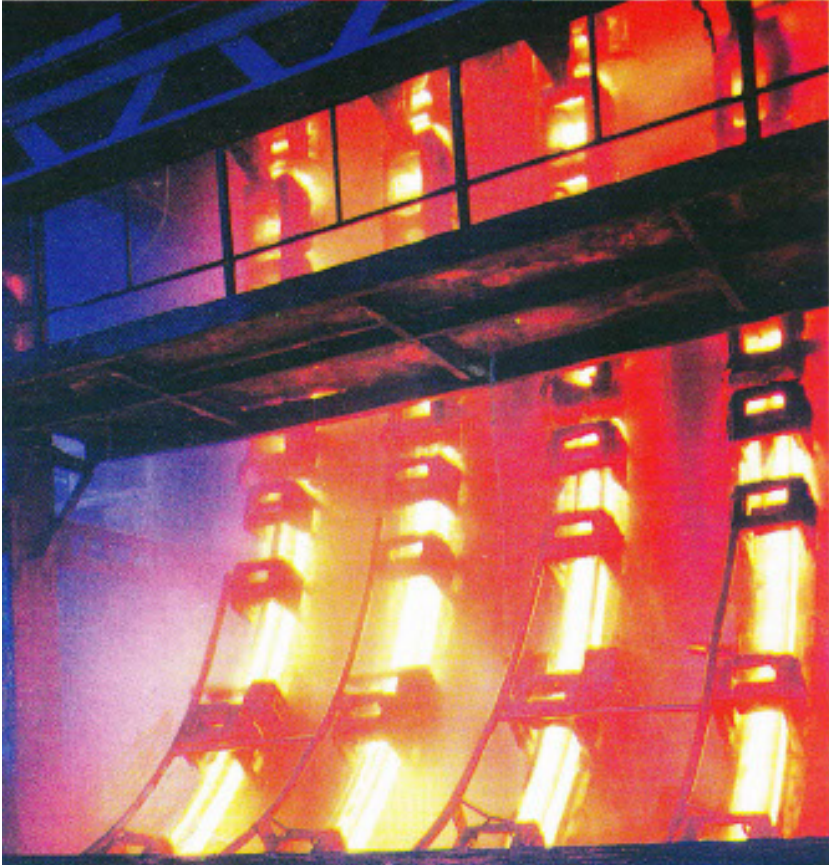
The Republic has been turned into a country with independent politics, the self-supporting economy and self-reliant defense capability.

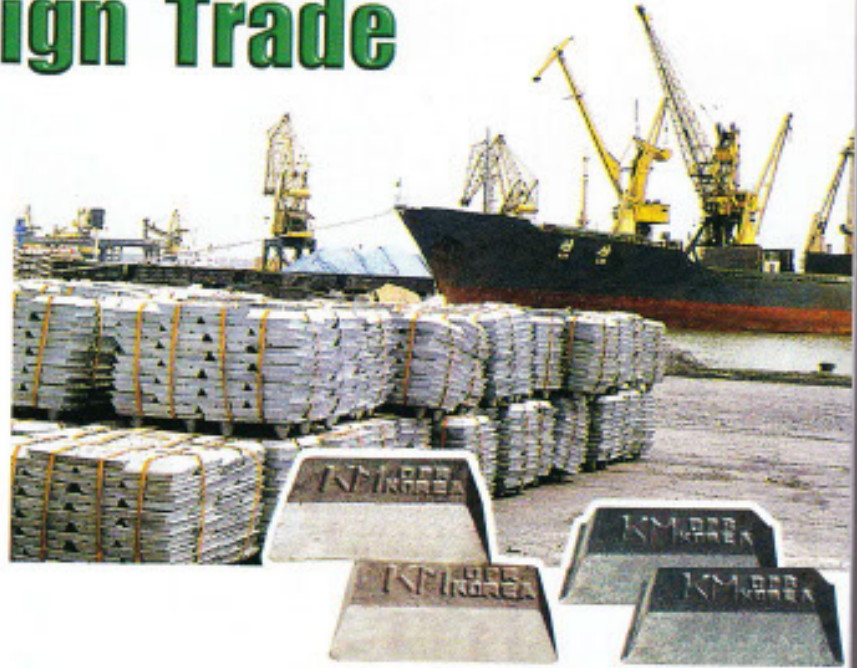


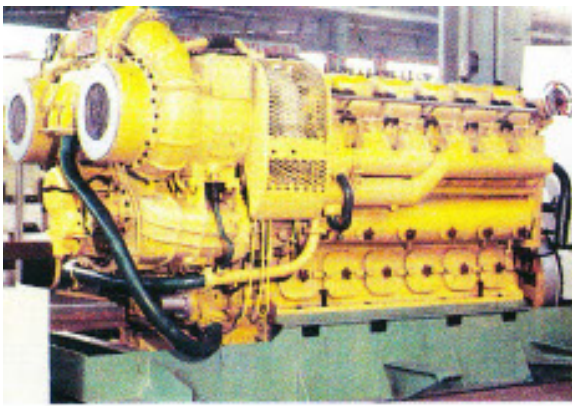

GPS Tracking System AnyTrac



AnyTrac is a web server integrated with trackers, GPS, mobile operators and the internet.

To institutions and individuals who are concerned about the security of their moving objects, the Korea Computer Center recommends AnyTrac—a perfect solution for close surveillance and satisfactory command on moving assets.

The trackers attached to moving assets include a built-in GPS receiver, a mobile phone, sensors and control outputs, enabling reports and commands to and from a server.

The system sends an alarm in the form of SMS, e-mail, live or pending messages in response to an incident.

Interaction with the system through mobile SMS is also supported.

Users can edit machine intelligence sets, which are then shared by all users on the server and terminals to monitor moving objects and review their travel history.

The center also has a detailed program to turn mobile phones into trackers of the system with no hardware modification for easy tracking of mobile phone users.

The users will benefit from the system in monitoring moving persons and assets, taking care of children, special security, visualizing the progress of travel situation, monitoring mobile work force, etc. thanks to its user-controlled sensors, vivid satellite images, full reproduction of travel history, smart interpolation of track and so on.

Heavy Industry—A Sure Guarantee for Development of Foreign Trade

Heavy industry constitutes the foundation for the development of the national economy.

Since its founding, the DPRK government has pursued the revolutionary line of building a self-supporting heavy industry for political independence and independent progress of the country and directed primary efforts into developing the heavy industry with the machine-building industry as its core.

President Kim Il Sung said long ago in reflection of the lawful requirements of the revolution and construction that the line of building an independent heavy industry is, firstly, to equip all sectors of the heavy industry with advanced technology, secondly, to develop them relying on domestic natural resources and sources of raw materials and, thirdly, to expand them in an all-round way so as to produce and supply the means of production necessary for the national economy on their own, and indicated the orientation and ways for its implementation.

SGS Pyongyang Office

The SGS Pyongyang Office represents the SGS, the world's renowned inspection network, in the DPRK.

The office offers SGS inspection service on export and import goods requested by the domestic trading corporations in regular contact with the SGS, which has its head office in Geneva and some 1 000 branch offices over the world and more than 330 laboratories in over 140 countries, while assisting the international accreditation of the DPRK's major exports as well as production and management systems.

Recently, George Bottomley, vice-president of the SGS, visited Pyongyang and had a discussion on practical issues with Pak Jong Ung, director of the SGS Pyongyang Office, and staffs.

It is an international trade practice to get a technical inspection from a third party rather than domestic inspection authorities and to conduct commercial transactions under the term of SGS inspection.

The office renders inspection service to domestic

trading corporations that are willing to export such products as magnesia clinker and machine tools under the inspection of the SGS so as to prevent disputes caused by poor quality and enhance the international competitiveness of the DPRK's export goods.

It also provides prompt and precise SGS inspection service by proxy in case the domestic trading corporations want to import goods of strict quality requirement from supplier's country through the field inspection before shipment.

Besides, the office cooperates the introduction of international accreditation of quality management, environment, and foodstuff and pharmaceutical production systems like ISO9000, ISO14001, ISO22000, HACCP and GMP into the up-to-date manufacturing centers in the DPRK so that they can mass-produce quality goods in conformity with international standards and the demand of the markets.

My Impressions in Pyongyang

I took part in the Pyongyang Spring International Trade Fair for the first time and the fair impressed me a lot.

It was a large and well-arranged fair.

The fair made a tangible contribution to the friendship and cooperation between countries.

Cooperation and Exchange for Investment and Development

(An interview of the reporter with Hyon Chol, president of the Korea International Investment Development Corporation)

Reporter: Would you mind telling me about the government policy and investment climate in the DPRK?

Our laws are featured by a small number of taxes and low tax rate imposed on foreign-invested enterprises and investors.

The DPRK is provided with favorable economic and geopolitical environments.

Our country borders with the three provinces in the northeastern China and the Far East region of Russia endowed with colossal labor power, intellectual and material resources, and is located in geographically favorable position for the raw materials and commodity markets.

Abundant underground resources, big processing capacity, quality work force, communications, banking service—they all constitute excellent conditions for investors in business activities within the territory of the DPRK.

Intact natural environment and able scientists and technicians also attract the interest of many foreign investors as well.

Which are the priority sectors in investment?

Power industry is one of the priority sectors.

In recent years large-scale and minor hydropower stations have gone online and many others are under construction, but the demand for electricity soars up in various fields of the national economy which develops rapidly day by day. Therefore, their capacity cannot keep up with the increasing demand.

That is the reason why power

industry requires heavy investment for updating equipment and perfecting its structure.

Korea has rich deposit of valuable minerals including nonferrous minerals like copper, lead and zinc, rare-metallic minerals as radium, titanium and molybdenum and ferrous minerals including iron ore and non-metallic minerals. Therefore, investment in this sector will pay off in a short period.

Investment is also needed in various sectors such as electronic and light industries, agriculture and public health.

What about the present situation of foreign investment in the DPRK and its prospect in the future?

The number of investors increases as days go by in accordance with the enhancement of international prestige of the Republic and expansion of trade and economic exchange and cooperation.

Foreigners are investing independently or through equity or contractual joint venture in the DPRK.

With investment activities animated in recent years, substantial and mutual profit is made on the investment in various sectors, thus enlarging the investment volume and widening the scope of investment fields. Business forums and investment conferences are frequently held.

We will not only encourage such positive progress but also welcome foreign investors who seek a new investment opportunity in the DPRK.

Promising Joint Venture in DPRK

The DPRK government is consistently pursuing the policy of encouraging joint venture with various countries over the world.

Leader Kim Jong Il said:

"Since the publication of the Law on Equity Joint Venture, many countries have expressed their hope to carry on economic collaboration and technical exchange with our country."

IP Rights System & Technology Trade in DPRK

(An interview of the reporter with Dr. Kim Hung Han of the Moranbong Patent and Trademark Agency)

Reporter: Would you mind telling me about the DPRK's intellectual property rights system?

Dr. Kim: At present the intellectual property rights system in the DPRK is developing in keeping with the global trend.

The DPRK government puts greater emphasis on brainpower than ever before to meet the requirements of IT era.

The keen scientific and technological competition urgently demands all countries to develop their own science and technology.

Therefore, the DPRK is concentrating its efforts on the introduction of advanced technology while increasing the investment in the scientific and technological development.

The DPRK has already promulgated IPR-related laws including the laws on invention, trademark, industrial design, copyright and the appellation of origin.

The birth of intellectual property rights system has greatly affected the development of productivity and the system is a strong propellant for the development of society and economy.

The DPRK acceded to the WIPO in 1974 and signed various international conventions and agreements including Madrid Agreement for the Repression of False or Deceptive Indications of Source on Goods, Paris Convention for the Protection of Industrial Property, Patent Cooperation Treaty, Berne Convention for the Protection of Literary Works, Lisbon Agreement for the Protection of Appellations of Origin and their International Registration and is faithfully observing their requirement.

The Moranbong, Pyongyang, Ryongsan, Taedonggang and some other patent and trademark agencies are making brisk business and the patent technologies are encouraged under

legal protection.

What about the actual conditions of technology trade?

Nowadays the share of patent and technology trade is increasing day by day in our country.

Thanks to the great vitality of the government policy of attaching importance to science and technology, up-to-date scientific and technological achievements were made and introduced into various fields of the national economy.

Besides, a large number of trading corporations adopt their business strategy with technology trade as a core.

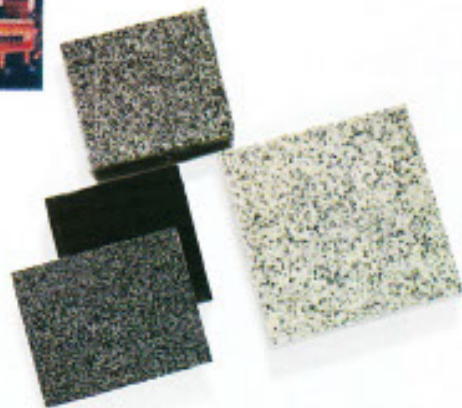
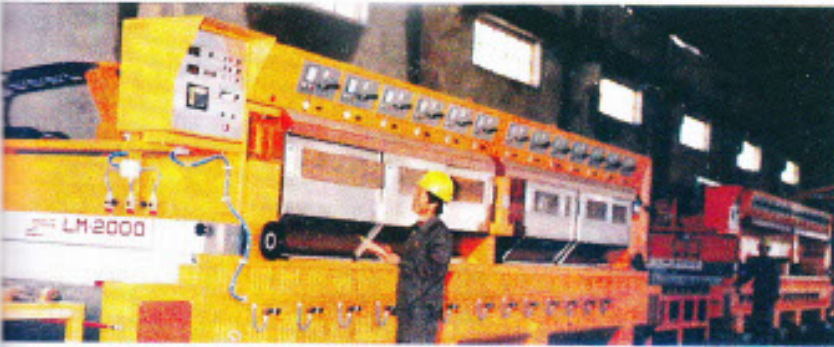

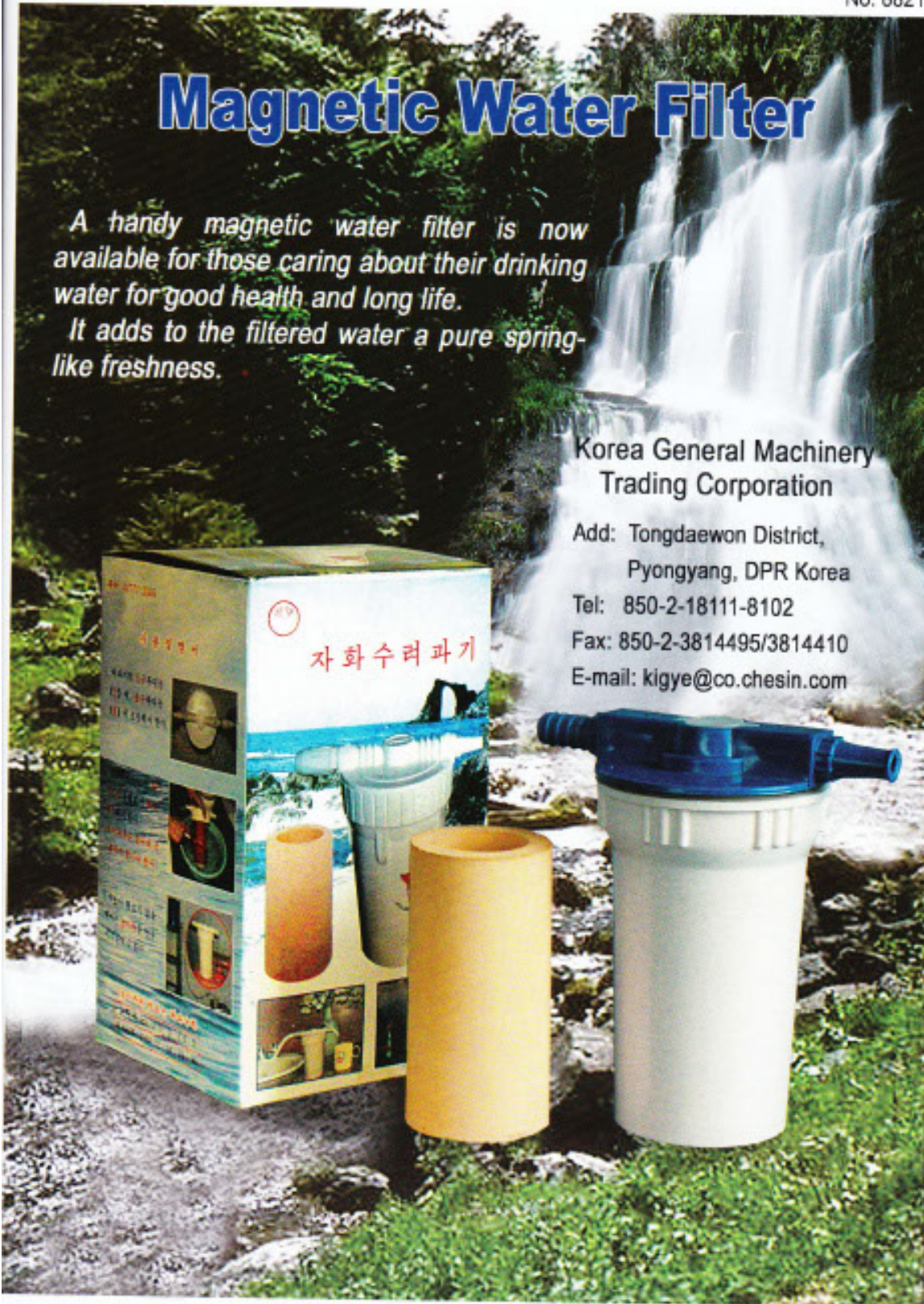
